- Preface by Michael Roper: “Indeed in most literate civilizations the earliest records to be created were those of legal title to property and of judicial decisions by the courts, and it was to house such records that the earliest archives were established.
It is thus surprising that legal records should have been the object of comparative neglect in recent times. Perhaps because they are much more likely than other kinds of records to have a self-evident continuing primary value as evidences of rights and obligations which may endure long beyond the lifespans of those who created them, their secondary value for the light they shed on the origins, structures, functions and procedures of legal administration itself or, incidentally, on wider economic political or social issues tends to be discounted.”
